


RC/W Newsletter 2 (December 2022)

A note from our Project Director, Andrea Doucet:


Hello colleagues and friends,

We are sharing some of our news and updates from the Reimagining Care/Work Policies project from this past year.

Next year we are moving to a biannual newsletter, which will include updates in late spring and an end of year recap in late fall.

This past spring, we welcomed back our Project Manager, Jennifer Turner from maternity and parental leave. Ashley Do Nascimento, our interim Project Manager while Jenn was on leave, is now focussing on her PhD and other work. Before she left, she did an excellent job as coordinator of our first in-person event in June (*What Now for Child Care?*). We wish her all the best.

1. EVENTS

What Now for Child Care?

This summer, with the leadership of <u>Childcare Resource and Research Unit</u> and <u>Child Care Now</u>, we hosted our first event, "What Now for Child Care". This two-day policy symposium gathered over 60 researchers, Indigenous experts, advocates, policy makers and child care sector stakeholders from across Canada to take stock of how far early learning and child care policy has come on the path to a quality, inclusive early learning and child care (ELCC) system for all. A follow-up to this event is a four-part webinar series, "What's Next for Early Learning and Child Care?". This series, which runs from November 15 2022 to January 31 2023, discusses the rollout of the Canada-Wide Early Learning and Child Care agreements (CWELCC) and takes a look at what must be done to build a system of accessible, affordable, inclusive and high quality early learning and child care that supports all children and families. Two webinars have already taken place: "What's next for the ELCC workforce" and "What's next for Indigenous ELCC". The next webinar in the series, "What's next for ELCC affordability?", will take place on January 17th at 7:00pm EST. 2022 Conferences

Our team presented several conference papers and presentations during the spring/summer academic conference season (including the online Congress of the Social Sciences and Humanities; the online Canadian Sociological Association; the Work Family Research Network conference in New York; and the Annual Seminar of the International Network of Leave Policies and research). We regularly post publications on our website, and we will post ones that result from our conference papers.

Looking Ahead

We were hoping to have a team event in 2023, but the cancellation or postponement of many conferences in the last few years due to COVID-19 has meant that 2023 is an extremely busy conference year. We are planning to meet up with colleagues at the Congress of Social Sciences and Humanities at York University in June. We are also in the early stages of some team events in 2024. We will share news in due course.

2. PROJECTS

Open Educational Learning Resources

We have launched a new suite of Open Educational Resources free to teachers and students learning about Canada's family policy landscape. The resources were created by the RC/W knowledge mobilization team led by Dr. Lindsey McKay (Thompson Rivers University) and graduate students Marco Sasso (Brock University) and Kenya Thompson (York University). The first media/learning bundle provides an overview of Child Care in Québec, created in collaboration with Dr. Sophie Mathieu. In the video and the accompanying resources, Dr. Mathieu explains child care in Québec in terms of affordability, quality, and accessibility, identifying what lessons Canada can draw from it in developing a national child care program. Canadian and International Familydemic survey

In the summer of 2021, we conducted a national survey with Angus Reid, on the work and care lives of diverse Canadian families through the pandemic in ten Canadian provinces and with 4,685 respondents. This survey was part of an international comparative survey team developed with six countries: Canada, Germany, Italy, Poland, Sweden, and the United States.

We've had our first manuscript accepted: "Familydemic Cross Country and Gender Dataset on work and family outcomes during COVID-19 pandemic" in the highly ranked journal *Scientific Data* by: Anna Kurowska (University of Warsaw), Ilyar Barardehi (University of Warsaw), Sylvia Fuller (University of British Columbia), Richard Petts (Ball State University), Gayle Kaufman (Davidson College), Andrea Doucet (Brock University), Cassandra Engeman (Stockholm University), Anna Matysiak (University of Warsaw), Raffaele Guetto (University of Florence), Thordis Reimer (University of Hamburg), Tsegachew Kasegn (University of Warsaw), Daniele Vignoli (University of Florence), Ann-Zofie Duvander (Mid Sweden University and Stockholm University), and Shirley Gabel (Fordham University).

We are also working on several Canadian papers, with comparative papers in process as well. We will share more in our next newsletter and on our website.



Care/Work Portrait Project: A Qualitative Research Study Exploring How Diverse Canadian Families Organize, Strategize, and Manage Paid and Unpaid Work

As a follow-up to the national survey, we developed a qualitative research study which involves interviewing individuals and couples about their care and work lives with a view to understanding key contemporary issues and challenges for diverse Canadian families on paid and unpaid work. We developed a method and digital app, the Care/Work Portrait, to explore paid and unpaid work, and gender divisions and relations of household and care work. We are conducting research with a wide range of families, including Indigenous, new immigrant and racialized, LGBTQ, rural, low-income families, families with disabilities, and families with particular configurations of paid and unpaid work (i.e., one partner working in the care economy, and households where fathers took parenting leaves and/or flexible/remote work).

We currently have two project background publications in press:

Kim de Laat, who was working with Andrea Doucet as a Mitacs Postdoctoral Fellow, is an Assistant Professor of Organization and Human Behaviour at the University of Waterloo's Stratford School of Interaction Design and Business. One of Kim's core research and teaching goals is to critically examine how the social organization of work influences worker well-being, and how this varies on the basis of gender, parental status, and race/ethnicity.

<u>Sadie Goddard-Durant</u>, who was working with Andrea Doucet, is the Director of Knowledge Mobilization and Research at Luke's Place, an NGO which provides family law support to women and children after they leave an abusive relationship. Sadie provides strategic guidance and oversight of the delivery of Luke's Place innovative knowledge mobilization and research programs.

Janna Klostermann, who was working with Andrea Doucet as a SSHRC Postdoctoral Fellow, is a tenure-track assistant professor in the Department of Sociology at the University of Calgary. She will expand on her program of research and will teach courses this coming year in the sociology of health and in the sociology of work.

<u>Sophie Mathieu</u>, who was working with Diane-Gabrielle Tremblay, is the Senior program specialist at the Vanier Institute of the Family. Sophie is responsible for building partnerships with different organizations, researchers, advocates and policy makers with an interest on family wellbeing.
